

## **Online Submission**

All submissions are handled online at <http://ees.elsevier.com/rsue/>. Once you have logged on as author using your JOURNAL username and password you will be guided through the creation and uploading of your source files. The system automatically converts source files to a single Adobe Acrobat PDF version of the article, which is used in the peer-review process. Note that your manuscript should be submitted as a source file which means in any of the Word processing file or Latex but not as a PDF. Please note that even though manuscript source files are converted to PDF at submission for the review process, these source files are needed for further processing after acceptance. A PDF file is not considered a source file. All correspondence, including notification of the Editor's decision and requests for revision, takes place by e-mail and via the Author's homepage only. Therefore users need to keep their contact coordinates on the registration page up-to-date with the "UPDATE MY INFORMATION" option.

Prior to submitting your manuscript, you are strongly encouraged to visit the submission checklist below.

### **Submission checklist**

- One Author designated as corresponding Author, with e-mail address, full postal address, and telephone/fax numbers
- Author has visited Regional Science and Urban Economics website to review information on journal policies
- Manuscript is in 12 point type and in double space mode
- Manuscript main text does not exceed 40 pages
- All tables and figures appear at the back of the manuscript
- Any not-for-publication appendices appear at the back of the manuscript and are clearly identified as such
- JEL codes(s) and keywords are included
- All figures contain captions
- All tables include title, description, footnotes
- Manuscript has been "spellchecked"
- References are in the correct format for this journal
- All references mentioned in the Reference list are cited in the text, and vice versa
- Permission has been obtained for use of copyrighted material from other sources (including the Web)
- Authors may optionally specify a list of potential referees-not including co-authors, colleagues, advisors or students- and a list of individuals that should not referee the manuscript with an explanation for the exclusion.

- All necessary files are uploaded including text, figures tables, appendices, and correspondence.

### **Word processors**

Save the file in the native format of the word processor used. The text should be in single-column format. Keep the layout of the text as simple as possible. Most formatting codes will be removed and replaced on processing the article. In particular, do not use the word processor's options to justify text or to hyphenate words. However, do use bold face, italics, subscripts, superscripts etc. Do not embed "graphically designed" equations or tables, but prepare these using the word processor's facility. When preparing tables, if you are using a table grid, use only one grid for each individual table and not a grid for each row. If no grid is used, use tabs, not spaces, to align columns. Do not import the figures into the text file but, instead, indicate their approximate locations directly in the electronic text. To avoid

unnecessary errors you are strongly advised to use the "spellchecker" function of your word processor.

## **Article**

*Language.* Articles must be written in clear and correct English.

*Title.* Concise and informative. Avoid abbreviations and formulae.

*Author names and affiliations.* Where the family name may be ambiguous (e.g., a double name), please indicate this clearly using appropriate script (capital cases as first letter of authors' first and surnames followed by lower cases). The Present Authors' affiliation addresses (where the actual work was done) should be written below their names and surnames. Indicate all affiliations with a lower-case superscript letter immediately after the Author's name and in front of the appropriate address. Provide the full postal address of each affiliation, including the country name, and, if available, the e-mail address of each Author.

*Corresponding Author.* Clearly indicate who will handle correspondence at all stages of refereeing and publication, also post-publication. Only the corresponding author will receive correspondence from the Journal. Ensure that telephone and fax numbers (with country and area code) are provided in addition to the e-mail address and the complete postal address.

*Abstract.* A concise abstract should briefly state the purpose of the research and the main results. An abstract is often presented separate from the article, so it must be able to stand alone.

*Classification codes and keywords.* Provide at least one standard JEL code <http://www.aeaweb.org/journal/elclasjn.html> and up to 5 additional keywords.

*Illustrations.* Graphics files can be uploaded via <http://ees.elsevier.com/regec>. A guide on electronic artwork is available on <http://authors.elsevier.com/artwork>

Most of the time figures and tables can be found at the end of the built pdf. If you use Latex format, the figures/tables will be embedded into the manuscript.

Appendices may be uploaded as a 'Supplementary Material', a type of a Submission Item. Supplementary materials should either be referred to from within the text of the manuscript in the same way as for figures or tables, or their presence be indicated by adding a paragraph entitled 'Supplementary data' at the end of the manuscript, detailing with data are supplied.

## *References*

All citations in the text should refer to:

- Single Author: the Author's name (without initials, unless there is ambiguity) and the year of publication;
- Two Authors: both Authors' names and the year of publication;
- Three or more Authors: first Author's name followed by "et al." and the year of publication.

Examples: "as demonstrated in (Allan, 1996a, 1996b, 1999; Allan and Jones, 1995). Lee et al. (2000) have recently shown"

In the references list references should be arranged first alphabetically and then further sorted chronologically if necessary. More than one reference from the same Author(s) in the same year must be identified by the letters "a", "b", "c", etc., placed after the year of publication.

Examples:

**Reference to a journal publication:**

-Griffiths, W., Judge, G., 1992. Testing and estimating location vectors when the error covariance matrix is unknown. *Journal of Econometrics* 54, 121-138 (note that journal names are not to be abbreviated)

**Reference to a book:**

-Maddala, G.S., 1983. *Limited Dependent and Qualitative Variables in Econometrics*. Cambridge: Cambridge University Press.

**Reference to a chapter in an edited book:**

-Reinganum, J., 1989. The timing of innovation: research development and diffusion. In: Schmalansee, R., Willig, R. (Eds.). *Handbook of Industrial Organization*, Vol. I. Amsterdam: North-Holland, 849-908.

*Reprints*. The corresponding author, at no cost, will be provided with a PDF file of the article via e-mail or, alternatively, 25 free paper offprints. This PDF file is a watermarked version of the published article and includes a cover sheet with the journal cover image and a disclaimer outlining the terms and conditions of use.
