DESCRIPTION

The *Scandinavian Journal of Pain*, the scientific journal of the researcher-network **Scandinavian Association for the Study of Pain** (www.SASP.org), is a comprehensive forum for original research from international researchers, on all aspects of pain including the nature of pain, pain mechanisms, and pain management. In order to bring pain-researchers and pain-clinicians up-to-date on important issues, the journal also encourages submissions of topical reviews.

Scandinavian Journal of Pain provides a broad and stimulating approach to new pain-related research by also commissioning *editorial comments* published together with *all accepted papers*. The editorial comment highlights the significance of the research in the paper and often provides a concise review of the topic of the paper. This puts the papers into context of the present climate of pain research.

Scandinavian Journal of Pain is primarily an online journal, and it also publishes a condensed print version for its subscribers. This paper-version prints the *editorial comments*, the *extended abstracts*, and the *Highlights* of the online-published papers. This provides the essence of the research and its importance in the care or future care of patients.

The editorial comments and the Editor's choice paper in each issue are currently available as Free for View on ScienceDirect and www.scandinavianjournalpain.com. All articles published in the *Scandinavian Journal of Pain* are indexed in Scopus/Science Direct and EMBASE.

Scandinavian Journal of Pain publishes these categories of articles: Basic and clinical research; systemic and topical reviews; hypothesis-generating case-reports and observational studies; letter to the Editor. GUIDE FOR AUTHORS

Your Paper Your Way

We now differentiate between the requirements for new and revised submissions. You may choose to submit your manuscript as a single Word or PDF file to be used in the refereeing process. Only when your paper is at the revision stage, will you be requested to put your paper in to a 'correct format' for acceptance and provide the items required for the publication of your article.

INTRODUCTION

Papers accepted for publication in the *Scandinavian Journal of Pain* will be published in 2 formats in this *hybrid journal*:

- 1) an extended abstract together with an editorial comment, in the printed paper-version of the Journal
- 2) in full on ScienceDirect and the Journal website (<http://www.ScandinavianJournalPain.com>). All articles remain fully citable and available to searches. They are indexed on Scopus/ScienceDirect and EMBASE

IMPORTANT MESSAGE

Articles can only be submitted online via the Elsevier Editorial System at <http://ees.elsevier.com/sjpain>. Before you can upload your manuscript you will need to register to the program as an author. An individual username and a password will be sent to you. Please make sure that your manuscript is in accordance with the Guide for Authors given below.

Types of article

The *Scandinavian Journal of Pain* publishes high quality reports on original basic and clinical research; comprehensive systematic and topical reviews; hypothesis-generating case-reports and observational studies; letter to the Editor.

Basic and Clinical Research

Word limit; Abstract : 500 words, Introduction : 500 words, Methods : no limit; Results : no limits; Discussion : 1500 words. Follow CONSORT-guidelines when planning and reporting clinical trials (<http://www.consort-statement.org>), and ARRIVE-guidelines when planning and reporting animal studies (<http://www.nc3rs.org.uk/ARRIVE>).

Please refer to ethics for guidelines for reporting on animal studies or clinical trials (ethics and clinical trials).

Comprehensive Systematic Reviews and Topical Reviews

Topical reviews focus on recent research and development of important issues in pain medicine. Comprehensive reviews can include meta-analysis when appropriate or be narrative when meta-analysis is not possible. Follow the **PRISMA** (formerly QUOROM) guidelines for reporting systematic reviews and meta-analysis (<http://www.prisma-statement.org>).

Word limit : 6000 words.

Case-reports and observational studies

Should describe new and important observations that may generate hypothesis that can subsequently be tested in proper clinical trials. Word-limits: These should generally be brief reports (no longer than 4000 words).

Letters to the Editor

Letters containing critical assessment of papers recently published in the *Scandinavian Journal of Pain* will be considered for publication in the correspondence section. Letters should not exceed 1000 words including references as necessary, one table or one figure. Letters should be typed in double spacing, should have a heading and no abbreviations. If related to a previously published article, the article should be identified by title, author(s), and volume/page numbers. All letters are subject to editorial review. At the Editor's discretion, a letter may be sent to authors of the original paper for comment, and both letter and reply may be published together.

Additional Material

The submission needs to be accompanied by a covering letter to the editor.

Your cover letter should include the following:

Title, authors, number of pages, and number of tables and figures. Indication that all the authors have read and approved the paper. Description of how each author contributed to the manuscript and others who may have assisted. Name of type of paper. Information about any previous presentation of the data (e.g., at a specific meeting or as a thesis). Information about the existence of any closely related manuscripts that you have submitted for simultaneous consideration to the same or another journal. Notice of any interests that might be seen as influencing the research (e.g., financial interest in a test or procedure, funding by pharmaceutical companies for drug research, etc.). A copy of the permission granted to reproduce or adapt any copyrighted material from another source or a notice that permissions are pending. Indicate the original source(s) in the legend of the illustration, or as appropriate in a footnote to the text. Please submit the CONSORT-check-list for articles that cover clinical trials, the ARRIVE-checklist for animal studies, and the PRISMA checklist for systematic reviews. Names of three potential reviewers with complete contact details. As our objective is to obtain independent reviews that are free from bias, please do NOT suggest people with whom you have worked or published in recent years or anyone who works at your institution. There is no assurance that the editors will choose reviewers from the list you provided.

BEFORE YOU BEGIN

Ethics in publishing

Please see our information pages on [Ethics in publishing](#) and [Ethical guidelines for journal publication](#).

Human and animal rights

If the work involves the use of human subjects, the author should ensure that the work described has been carried out in accordance with [The Code of Ethics of the World Medical Association](#) (Declaration of Helsinki) for experiments involving humans; [Uniform Requirements for manuscripts submitted to Biomedical journals](#). Authors should include a statement in the manuscript that informed consent was obtained for experimentation with human subjects. The privacy rights of human subjects must always be observed.

All animal experiments should comply with the [ARRIVE guidelines](#) and should be carried out in accordance with the U.K. Animals (Scientific Procedures) Act, 1986 and associated guidelines, [EU Directive 2010/63/EU for animal experiments](#), or the National Institutes of Health guide for the care and use of Laboratory animals (NIH Publications No. 8023, revised 1978) and the authors should clearly indicate in the manuscript that such guidelines have been followed.

The protocol for interventional pain studies on humans should be approved by an institutional clinical research board/committee.

Ethics of Animal Experiments

Work described in your article that deals with animal experiments just follow the guidelines listed hereunder.

The experiments must adhere to the guidelines of the Committee for Research and Ethical Issues of IASP [http://www.iasp-pain.org/AM/Template.cfm?Section=Animal_Research]. The study-protocol should be reviewed by an institutional animal care and use committee.

When reporting animal pain research, please follow the ARRIVE Guidelines (Rice A SC et al. Scand J Pain 2013;4:58-62; Kontinen VK Scand J pain 2013;4:57.) <http://www.nc3rs.org.uk/page.asp?id=1357>.

Declaration of interest

All authors must disclose any financial and personal relationships with other people or organizations that could inappropriately influence (bias) their work. Examples of potential conflicts of interest include employment, consultancies, stock ownership, honoraria, paid expert testimony, patent applications/registrations, and grants or other funding. If there are no conflicts of interest then please state this: 'Conflicts of interest: none'. [More information](#).

Submission declaration and verification

Submission of an article implies that the work described has not been published previously (except in the form of an abstract or as part of a published lecture or academic thesis or as an electronic preprint, see '[Multiple, redundant or concurrent publication](#)' section of our ethics policy for more information), that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities where the work was carried out, and that, if accepted, it will not be published elsewhere in the same form, in English or in any other language, including electronically without the written consent of the copyright-holder. To verify originality, your article may be checked by the originality detection service [CrossCheck](#).

Changes to authorship

Authors are expected to consider carefully the list and order of authors **before** submitting their manuscript and provide the definitive list of authors at the time of the original submission. Any addition, deletion or rearrangement of author names in the authorship list should be made only **before** the manuscript has been accepted and only if approved by the journal Editor. To request such a change, the Editor must receive the following from the **corresponding author**: (a) the reason for the change in author list and (b) written confirmation (e-mail, letter) from all authors that they agree with the addition, removal or rearrangement. In the case of addition or removal of authors, this includes confirmation from the author being added or removed.

Only in exceptional circumstances will the Editor consider the addition, deletion or rearrangement of authors **after** the manuscript has been accepted. While the Editor considers the request, publication of the manuscript will be suspended. If the manuscript has already been published in an online issue, any requests approved by the Editor will result in a corrigendum.

Reporting clinical trials

Randomized controlled trials should be presented according to the CONSORT guidelines. At manuscript submission, authors must provide the CONSORT checklist accompanied by a flow diagram that illustrates the progress of patients through the trial, including recruitment, enrollment, randomization, withdrawal and completion, and a detailed description of the randomization procedure. The [CONSORT checklist and template flow diagram](#) are available online.

Clinical trials

Please submit the CONSORT check-list with the cover-letter to the Editor. In addition, authors should consider describing the outcome measures following the IMMPACT recommendations (Dworkin et al., Pain 2005:113;9-19).

All trials initiated after July 1, 2005 must be registered in a publicly accessible registry before patient inclusion has begun. The name of the registry and the registry number must be included in the method section. Examples of acceptable registries: WHO International Clinical Trials Registry Platform (ICTRP) and ClinicalTrials.gov.

We also recommend that the protocols for systematic reviews be registered at PROSPERO (www.crd.york.ac.uk/prospero/).

Registration of clinical trials

Registration in a public trials registry is a condition for publication of clinical trials in this journal in accordance with [International Committee of Medical Journal Editors](#) recommendations. Trials must register at or before the onset of patient enrolment. The clinical trial registration number should be included at the end of the abstract of the article. A clinical trial is defined as any research study that prospectively assigns human participants or groups of humans to one or more health-related interventions to evaluate the effects of health outcomes. Health-related interventions include any intervention used to modify a biomedical or health-related outcome (for example drugs, surgical procedures, devices, behavioural treatments, dietary interventions, and process-of-care changes). Health outcomes include any biomedical or health-related measures obtained in patients or participants, including pharmacokinetic measures and adverse events. Purely observational studies (those in which the assignment of the medical intervention is not at the discretion of the investigator) will not require registration.

Copyright

Upon acceptance of an article, authors will be asked to complete a 'Journal Publishing Agreement' (see [more information](#) on this). An e-mail will be sent to the corresponding author confirming receipt of the manuscript together with a 'Journal Publishing Agreement' form or a link to the online version of this agreement.

Subscribers may reproduce tables of contents or prepare lists of articles including abstracts for internal circulation within their institutions. [Permission](#) of the Publisher is required for resale or distribution outside the institution and for all other derivative works, including compilations and translations. If excerpts from other copyrighted works are included, the author(s) must obtain written permission from the copyright owners and credit the source(s) in the article. Elsevier has [preprinted forms](#) for use by authors in these cases.

For open access articles: Upon acceptance of an article, authors will be asked to complete an 'Exclusive License Agreement' ([more information](#)). Permitted third party reuse of open access articles is determined by the author's choice of [user license](#).

Studies on patients or volunteers require ethics committee approval and informed consent, which should be documented in the paper. Appropriate consents, permissions and releases must be obtained where an author wishes to include case details or other personal information or images of patients and any other individuals in an Elsevier publication. Written consents must be retained by the author and copies of the consents or evidence that such consents have been obtained must be provided to Elsevier on request. PREPARATION

NEW SUBMISSIONS

Submission to this journal proceeds totally online and you will be guided stepwise through the creation and uploading of your files. The system automatically converts your files to a single PDF file, which is used in the peer-review process.

As part of the Your Paper Your Way service, you may choose to submit your manuscript as a single file to be used in the refereeing process. This can be a PDF file or a Word document, in any format or layout that can be used by referees to evaluate your manuscript. It should contain high enough quality figures for refereeing. If you prefer to do so, you may still provide all or some of the source files at the initial submission. Please note that individual figure files larger than 10 MB must be uploaded separately.

References

There are no strict requirements on reference formatting at submission. References can be in any style or format as long as the style is consistent. Where applicable, author(s) name(s), journal title/book title, chapter title/article title, year of publication, volume number/book chapter and the pagination must be present. Use of DOI is highly encouraged. The reference style used by the journal will be applied to the accepted article by Elsevier at the proof stage. Note that missing data will be highlighted at proof stage for the author to correct.

Formatting requirements

There are no strict formatting requirements but all manuscripts must contain the essential elements needed to convey your manuscript, for example Abstract, Keywords, Introduction, Materials and Methods, Results, Conclusions, Artwork and Tables with Captions.

If your article includes any Videos and/or other Supplementary material, this should be included in your initial submission for peer review purposes.

Divide the article into clearly defined sections.

Figures and tables embedded in text

Please ensure the figures and the tables included in the single file are placed next to the relevant text in the manuscript, rather than at the bottom or the top of the file. The corresponding caption should be placed directly below the figure or table.

Peer review

This journal operates a single blind review process. All contributions will be initially assessed by the editor for suitability for the journal. Papers deemed suitable are then typically sent to a minimum of two independent expert reviewers to assess the scientific quality of the paper. The Editor is responsible for the final decision regarding acceptance or rejection of articles. The Editor's decision is final. [More information on types of peer review](#).

REVISED SUBMISSIONS

Use of word processing software

Regardless of the file format of the original submission, at revision you must provide us with an editable file of the entire article. Keep the layout of the text as simple as possible. Most formatting codes will be removed and replaced on processing the article. The electronic text should be prepared in a way very similar to that of conventional manuscripts (see also the [Guide to Publishing with Elsevier](#)). See also the section on Electronic artwork.

To avoid unnecessary errors you are strongly advised to use the 'spell-check' and 'grammar-check' functions of your word processor.

Article headings - numbered sections

Divide your article into clearly defined and numbered main sections (see below). The subsections should then be numbered 1.1 (then 1.1.1, 1.1.2, ...), 1.2, etc. (the abstract (500 words) is not included in section numbering). Use this numbering also for internal cross-referencing: do not just refer to 'the text'. Any subsection is given a brief subheading. Each heading/subheading should appear on its own separate line.

1. Introduction (limit to about 500 words)

2. Material and methods (no limits)

Provide sufficient detail to allow the work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described.

3. Results (no limits)

Results should be clear and concise.

4. Discussion (limit about 1,500 words)

This should explore the significance of the results of the work, not repeat them. A combined Results and Discussion section can be appropriate. Avoid extensive citations and discussion of published literature.

5. Conclusions

The main conclusions **based solely on the data** of the study.

6. Implications

What do the authors think their findings and conclusions mean: The wider interpretation and possible consequences of their findings?

Ethical issues

Please use this section to detail how issues relating to informed consent were handled. Also state whether or not Ethical Board/Ethical Committee approval of the study protocol was needed. Please confirm whether the study protocol was registered; and if so, where it was registered.

Conflicts of interest

State any potential conflicts of interest, as detailed above.

Appendices

If there is more than one appendix, they should be identified as A, B, etc. Formulae and equations in appendices should be given separate numbering: Eq. (A.1), Eq. (A.2), etc.; in a subsequent appendix, Eq. (B.1) and so on. Similarly for tables and figures: Table A.1; Fig. A.1, etc.

Essential title page information

- **Title.** Concise and informative. Titles are often used in information-retrieval systems. Avoid abbreviations and formulae where possible.
- **Author names and affiliations.** Please clearly indicate the given name(s) and family name(s) of each author and check that all names are accurately spelled. Present the authors' affiliation addresses (where the actual work was done) below the names. Indicate all affiliations with a lower-case superscript letter immediately after the author's name and in front of the appropriate address. Provide the full postal address of each affiliation, including the country name and, if available, the e-mail address of each author.
- **Corresponding author.** Clearly indicate who will handle correspondence at all stages of refereeing and publication, also post-publication. **Ensure that the e-mail address is given and that contact details are kept up to date by the corresponding author.**
- **Present/permanent address.** If an author has moved since the work described in the article was done, or was visiting at the time, a 'Present address' (or 'Permanent address') may be indicated as a footnote to that author's name. The address at which the author actually did the work must be retained as the main, affiliation address. Superscript Arabic numerals are used for such footnotes.

Page numbering

When preparing your files for submission, you must insert page numbers to your main manuscript file.

Structured abstract

A structured abstract, by means of appropriate headings, should provide the context or background for the research and should state its purpose, basic procedures (selection of study subjects or laboratory animals, observational and analytical methods), main findings (giving specific effect sizes and their statistical significance, if possible), and principal conclusions. It should emphasize new and important aspects of the study or observations.

NOTE: This abstract will also be published in the printed version of this hybrid journal, **with an editorial comment** prepared by the Editor. **Use 500 words** with the following **subheadings in bold (some variations allowed for reviews and case reports/observational studies): Background and aims Methods Results Conclusions** (based on your data) **Implications** (your opinion on what your findings mean) **References** should be avoided, but if essential, then cite the author(s) and year(s), as well as the [number] in the list of references of the paper. Non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself.

It is possible to submit a single illustration if considered essential to summarising the topic, accompanied by a short concise legend. Editorially approved color illustrations will be reproduced in color in the printed journal at no additional charge. Color reproduction is as outlined under the **Color Artwork** section below

Graphical abstract

Although a graphical abstract is optional, its use is encouraged as it draws more attention to the online article. The graphical abstract should summarize the contents of the article in a concise, pictorial form designed to capture the attention of a wide readership. Highlights

Units

Temperatures should be given in degrees Celsius and blood pressures in millimetres of mercury or kPa with the alternative units in parentheses. All other measurements including laboratory measurements should be reported in the metric system in terms of the International System of Units (SI), e.g. metre [m], litre [L], kilogram [kg].

Abbreviations should be limited and defined after the first use of the term.

Drug Names

Generic names of drugs should be used where possible. When quoting from specific materials on proprietary drugs, authors must state in parentheses the name and address of the manufacturer.

Math formulae

Please submit math equations as editable text and not as images. Formats

References

Text: Indicate references by number(s) in [square brackets] in line with the text-consecutively as they are cited. The actual authors can be referred to, but the reference number(s) must always be given.

List: Number the references [numbers in square brackets] in the list in the order in which they appear in the text.

Note **shortened form for last page number**. e.g., 51-9, and that **ALL authors** should be listed (et al. is not permitted), and **do NOT include issue number(s)**.

Title of publications in any non-English language should be written with [English translation in brackets]. Example:

[6] Breivik H, Stubhaug A. [Difficult drug reimbursement system for pain patients]. *Tidsskr Nor Laegeforen* 2013;133:130.

Personal communications, manuscripts in preparation and other unpublished data should not be cited in the reference list but may be mentioned in the text in parentheses.

Web references

As a minimum, the full URL should be given and the date when the reference was last accessed. Any further information, if known (DOI, author names, dates, reference to a source publication, etc.), should also be given. Web references can be listed separately (e.g., after the reference list) under a different heading if desired, or can be included in the reference list.

Data references

This journal encourages you to cite underlying or relevant datasets in your manuscript by citing them in your text and including a data reference in your Reference List. Data references should include the following elements: author name(s), dataset title, data repository, version (where available), year, and global persistent identifier. References in a special issue

Please ensure that the words 'this issue' are added to any references in the list (and any citations in the text) to other articles in the same Special Issue.

Reference management software
